# Understanding Climate Change

Climate change refers to long-term shifts in temperatures and weather patterns.

Climate describes how the weather has generally been in a particular location



## Context Analysis

### **Overview of Kenya**

Kenya, also referred to as the Pride of Africa is located in East Africa. Kenya boasts a population of over 50 million people with over 80% of this population being aged below 35 years (KNBS, 2019)

Kenya is known for its wildlife, ethletes and is a hotspot tourist destination. The backbone of her economy is tourism and rain fed agriculture, both of which are susceptible to climate change and extreme weather conditions.



Agriculture is the leading source of greenhouse gas emissions in the country, largely driven by enteric fermentation from livestock. Climate vulnerabilities in Kenya include, floods, droughts and increased temperatures

Kenya submitted an updated, more ambitious <u>Nationally Determined Contribution</u> (<u>NDC</u>) on December 24, 2020, with a commitment to reduce emissions by 32 percent by 2030 relative to the business-as-usual scenario and in line with its sustainable development agenda and national circumstances (USAID, 2024).

### **Climate change impacts on health**

During floods, there were water borne diseases such as Bilharzia, people lost lives, children had to drop out of school following evacuation exercise that was done by the government. Many had mental health challenges such as anxiety that resulted from an un-anticipated climate change event, depression and stress that resulted from loss of property and lives. There was also an increase in gender based violence cases that was attributed to scarce resources.

In Mathare some people who were displaced were raped, I have a cousin who was affected, as she was looking for a place to stay, she got raped by a man who pretended to be a good Samaritan.

# Amplifying Youth Voices

I experienced climate related callenges. I live in an iron sheet structure so when it rains sadly I am affected. This is never an issue when we have normal rainfall. In March this year, what I thought was normal rain turned to be

floods.

To address the situation, the government ordered the demolition of homes within 30-50 meters of the rivers, a two-day notice was given for relocation, but many houses, including mine, were unmarked. Residents scrambled to find shelter amidst the downpour and rising floodwaters.

Although my house was beyond the 50 meter range, I was still anxious. I strolled around looking for a cheaper alternative to stay as i weighed my options on what i could afford with my minimal resources as opportunities for income had also been affected. Unfortunately, I got home to find that my house had been demolished with

my parent's house."

For her, every flood and drought deepens the fight for survival and the dream of a brighter future.

### **City Shamba**

City Shamba is a food security initiative aimed at combating hunger and malnutrition in urban areas by promoting urban agriculture. Founded to improve urban livelihoods, it provides education, training, and urban gardens, with a focus on low-income areas. The initiative uses sustainable, agroecological, regenerative, and climate-smart agricultural technologies to build localized urban food systems. City Shamba has established an urban agriculture resource hub at Mama Lucy Kibaki Hospital for hands-on training. It targets schools, community groups, and individuals, offering training, inputs, consultancy services, and innovative gardening solutions to spread urban farming across Nairobi.
